Planning, Zoning, and Building Permits

By Resolution of the Town Board of Bristol on December 3, 2003 Amended July 2004,
April 11, 2005, January 2008, November 2017, January 2019, August 2019, March 9, 2020

No permit or certificate shall be issued, no approval shall be granted, no application shall be considered complete and no public hearing shall be scheduled or held until the fees described below have been paid in full.

Applicants shall be responsible for the additional costs, if any, charged to the Town by attorneys, engineers, and consultants for review of applicant's proposal and associated documentation prepared for compliance with various regulations.

Notes:

- 1. All spaces within exterior walls of a dwelling unit, exclusive of garages, basements, unheated porches & breezeways. (foot print and appendages.)
- 2. Applications for storage buildings, detached garages, carports, decks and pole barns shall be considered accessory buildings.
- 3. Fences, unless required for swimming pools shall not require a permit.
- 4. Agricultural buildings shall mean a structure designed & constructed to house farm implements, hay, grain, poultry, livestock or other horticulture products. This structure shall not be a place of human habitation, or a place of employment where agricultural products are processed, treated or packaged, nor shall it be a place used by the public.
- 5. All engineering and legal fees incurred by the Town of Bristol, in reviewing of any project submitted for municipal approval shall be paid for by applicant of the project. (Resolution passed June 9, 1986.)
- 6. *Sheds 50 square feet or less do not require a building permit and must be a minimum of 5' from other accessory buildings.
