Supervisor Green opened the public hearing at 6:30 PM and discussed the need for the local law. Attorney Kenyon discussed the consequences of not passing the override law. Supervisor Green invited comment on the proposed law. Bristol resident, Mrs. Napurski, 4494 Kear Rd, asked the purpose of the law. Council Member Stresing discussed the tax cap law is a check on local government spending.

Hearing no additional requests to be heard, Supervisor Green closed the public hearing at 6:40 PM.

Budget considerations for 2023. Transfer \$10,000 from 2022 contractual fund to the Park Improvement Fund. Budget \$10,000 for 2023 (I would like to seal the track in 2023) and \$7,500 for equipment for playground and park maintenance.

RESOLUTION Local Law #1 of 2022

Tax Cap Override
At a meeting of the Town Board of the Town of Bristol, at Town Hall, 6740 County Road 32, Canandaigua, NY,
Ontario County, State of New York, on
October 11, 2022

WHEREAS, it appears to be in the best interests of the Town of Bristol that it consider adoption of Local Law #1 of 2022, to override the limit on the amount of real property taxes that may be levied by the Town of Bristol pursuant to General Municipal Law section 3-c,

WHEREAS, such a proposed Local Law was drafted and reviewed by the Town Board, and was the subject of a public hearing by this Board on October 11, 2022; and further

RESOLVED, that the Town Board of the Town of Bristol, County of Ontario, State of NY is hereby authorized to adopt a budget for the fiscal year 2023 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal law section 3-c,

NOW, THEREFORE, upon a motion by Council Member Hart, seconded by Council Member Bolonda, it is

RESOLVED THAT, this Local Law, a copy of which is appended hereto, is hereby adopted and to be effective upon filing with the State of New York; and further

RESOLVED THAT, the Town Clerk and Town Attorney are directed to take such actions as maybe necessary to make said Local Law #1 of 2022, effective.

Section 1. Legislative Intent. It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Bristol pursuant to General Municipal Law section 3-c and to allow the Town of Bristol to adopt a budget for the fiscal

year 2023 that requires a real property tax levy in excess of the "tax levy limit" as defined in General Municipal Law section 3-c.

- **Section 2. Authority.** This local law is adopted pursuant to subdivision 5 of General Municipal Law section 3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board.
- **Section 3. Tax Levy Override.** The Town Board of the Town of Bristol, County of Ontario, State of New York is hereby authorized to adopt a budget for the fiscal year 2023 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law section 3-c.
- **Section 4. Severability.** In the event any clause, sentence, paragraph, subdivision or part of this local law or the application thereof to any person, firm, corporation or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined to in its operation to the clause, sentence, paragraph, subdivision or part of this local law or in its application to the person, individual, firm, corporation or circumstance, directly involved in the controversy in which such order or judgment shall be rendered.
- **Section 5. Effective Date.** This local law shall take effect immediately upon its adoption and filing with the Secretary of State.
