Sandy Riker, Secretary of the Planning Board, submitted their monthly report. They approved two lot line adjustments and parcel combination applications. They reviewed a Site Plan application for a home on Evert Road. They reviewed the amended application submitted by Crown Castle/Verizon for the tower on Buckelew Road.

Sandy Riker, Secretary for the Code Enforcement Officer, submitted the monthly report. Three permits were issued. Both Phil and Pete are registered for the FLBOA conference to receive their required training. He met with P.J. Eemrick to review an erosion plan for a proposed home on Evert Road.

Ron Wilson, Hwy Supt. submitted his monthly report. \The new excavator has arrived. The thumb was not correct, so it was sent back to fit up to the ditching bucket. They have taken delivery of 1400 tons of salt towards the contract, still need to take another 1400 tons before end of the year. The salt building cover has been ordered. The annual audit of the financial records for the year 2015 of the Supervisor, Town Clerk and Town Justice have been completed by the Town Board and all records were found to be in proper order.
