Sandy Riker, Secretary of the Planning and Zoning Boards, submitted their monthly report. There will be no meetings this month for the Planning or ZBA boards. The will be meeting with the Town Board for a Solar presentation. Several members will be attending a training session presentation by GFLRPC.

Sandy Riker, Secretary for the Code Enforcement Officer, submitted the monthly report. Five permits were issued. Eleven inspections were performed. Four annual fire inspections were done so far. He attended two training sessions during April.

Ron Wilson, Hwy Supt. submitted his monthly report. The new Car 1-pickup has arrived. They are in the process of grading the dirt roads. Krown came and desalted the dump trucks. They are replacing four cross culvert pipes on Forbes Road. The road side mowing will be done by the highway employees this year. Free compost has been offered to the Town by Tim Green. A motion to accept this was made by Jeff Bliss seconded by David Parsons. Roll call vote-Jeff Bliss-Yes, Lauren Bolonda-Yes, Robert Green-abstained, David Parsons-Yes and Fred Stresing-Yes. Carried. The speed limit was approved by NYSDOT for Vincent Hill Road at 45 mph.

Committee Reports- Tom Stevens submitted a written report on the Park. No news on the Grant from Senator Funke. The 5K run was enjoyed by all who attended. There is one being planned for the Fall. More than 20 vendors have signed up for Fun Day.

The Town Clerk submitted her monthly report. Bulk water sales were \$120.00.
